LIABILITY WAIVER, RELEASE, INDEMNITY AND ASSUMPTION OF THE RISK AGREEMENT

Liability Waiver

I hereby agree, on behalf of myself, my children, my parents, my heirs, assigns, personal representatives and estate, as follows:

I fully understand and acknowledge that: 1) there are risks and dangers associated with participation in the baseball events and activities which could result in bodily injury, paralysis or death; 2) the social and economic losses and/or damages, which could result from these risks and dangers described above, could be severe; 3) these risks and dangers may be caused by the action, inaction or negligence of the participant or the action, inaction or negligence of others, including but not limited to the Releasees named herein; 4) there may be other risks not known to us or are not reasonably foreseeable at this time. I expressly accept and assume such risks and responsibility for the losses and/or damages following such injury, disability, paralysis or death however caused and whether caused in whole or in part by the acts or failure to act and/or negligence of the Releasees named herein.

In consideration for my participation in the baseball events and activities sponsored by Sansei Baseball League, I, on behalf of myself, my children, my parents, my heirs, assigns, personal representatives and estate, do **HEREBY RELEASE, WAIVE, DISCHARGE, INDEMNIFY, HOLD HARMLESS AND COVENANT NOT TO SUE** Sansei Baseball and its members, directors, board, officers, sponsors, agents, vendors, and North High School, Los Angeles Unified School District, Torrance Unified School District including but not limited to their faculty, employees and administrators, and the City of Torrance (referred herein collectively for all purposes as "Releasees"), of and from any and all demands, actions, causes of action, claims of any kind or nature whatsoever, known and unknown, anticipated or unanticipated, past or present, pertaining to the claim for injuries and damages which may exist arising out of or related to the participation in the baseball events and activities sponsored by Releasees caused or alleged to be caused in whole or in part by the negligence or acts of the Releasees, attending public, spectators, coaches, and/or player participants.

If, despite this release, I, on behalf of myself, my children, my parents, my heirs, assigns, personal representatives and estate, make a claim against any of the Releasees, then I, on behalf of myself, my children, my parents, my heirs, assigns, personal representatives and estate will defend, indemnify and hold harmless Releasees for any and all damages, attorneys' fees, and costs incurred as a result of said claim.

I, on behalf of myself, my children, my parents, my heirs, assigns, personal representatives and estate, understand that photographs, videotapes, and other recordings may be made of me. I, on behalf of myself, my children, my parents, my heirs, assigns, personal representatives and estate, consent to the use of any photographs, pictures, film or videotape taken of me or provided by me for publicity, promotion, television, or any other use, and expressly waive any right of privacy, compensation, copyright or other ownership right connected to same.

CODE OF CONDUCT AGREEMENT

Code of Conduct

The Sansei Baseball League was founded in 1960 for the specific purpose of providing organized sports for the youth of the South Bay communities; one in which all players would have an equal opportunity to participate with the fundamental principles of teamwork, fair play, and good sportsmanship.

It is the League's responsibility, your responsibility, and the coaches' responsibility to provide the youth of our community, a positive program of service, training, development, and enrichment under good sound leadership in a wholesome atmosphere of warmth, caring, and understanding.

I understand children play sports in order to have fun, make new friends, and learn new skills. I will encourage my child to have fun and keep sports in its proper perspective. I understand that athletes do their best when they are emotionally healthy, so I will be positive and supportive.

I understand that mistakes are an inevitable part of the game and that people learn from their mistakes. I understand that all children are born with different abilities and that the true measure is not how my child compares to others, but how he/she is doing in comparison to his/her best self.

I will "Honor the Game." I understand the importance of setting a good example of sportsmanship to my child. No matter what others may do, I will show respect for all involved in the game including coaches, players, opponents, opposing fans, and umpires. I understand that umpires, coaches, and players make mistakes. If the umpire makes a "questionable" call, I will continue to respect the individual and be silent!

I understand that games can be exciting times for my child who is trying to deal with the action of the game, respond to umpires, teammates, and listen to coaches. I will not add to the confusion and will limit my comments to encouraging my child and other players for both teams.

I will not make negative comments about the game, coaches, umpires or teammates in my child's presence. I understand that this plants a seed, which can negatively influence my child's motivation and overall experience.

I will remember that the game is for youth – not adults.

I will ask my child to treat other players, coaches, parents, fans, and umpires with respect regardless of race, sex, creed or ability.

I (and my guest) will not engage in any kind of unsportsmanlike conduct with any official, coach, umpire, player, or parent such as booing and taunting or using profane language or gestures.

I understand if I have a complaint of any sort, I will go through the proper channels - parent rep or coach, who will make a formal inquiry to the Sansei League Board on my or the team's behalf.

I agree that if I fail to abide by the aforementioned rules and guidelines, I and/or my child will be subjected to disciplinary action that could include, but not limited to the following:

- a. Parental and/or child game suspension
- b. Game forfeiture

c. Parental and/or child season suspension

d. Team suspension
