



Liability Waiver

I hereby agree, on behalf of myself, the below named minors, my children, my parents, my heirs, assigns, personal representatives and estate, as follows:

I fully understand and acknowledge that: 1) there are risks and dangers associated with participation in the baseball events and activities which could result in bodily injury, paralysis or death; 2) the social and economic losses and/or damages, which could result from these risks and dangers described above, could be severe; 3) these risks and dangers may be caused by the action, inaction or negligence of the participant or the action, inaction or negligence of others, including but not limited to the Releasees named herein; 4) there may be other risks not known to us or are not reasonably foreseeable at this time. I expressly accept and assume such risks and responsibility for the losses and/or damages following such injury, disability, paralysis or death however caused and whether caused in whole or in part by the acts or failure to act and/or negligence of the Releasees named herein.

Acknowledgment of COVID-19 Risks. I understand that (a) the novel coronavirus SARS-CoV-2 and any resulting disease (together with any mutation, adaptation or variation thereof, "COVID-19") is extremely contagious and there is an inherent risk of exposure to COVID-19 in any place where people are present; (b) no precautions, including the protocols that will be implemented in connection with the baseball events and activities (collectively, the "COVID-19 Protocols"), can eliminate the risk of exposure to COVID-19; (c) people of all ages and health conditions, including healthy young people, have been adversely affected by COVID-19; (d) certain people have been identified by public health authorities as having greater risk based on their age or underlying medical conditions; and (e) exposure to COVID-19 can result in being subject to quarantine requirements, illness, disability, and other short-term and long-term health effects, including death, regardless of a person's age or health condition. I also acknowledge that the COVID-19 Protocols may prove inadequate to prevent the exposure and transmission of COVID-19 and that it is possible that from time to time persons present at the baseball events and activities or at any locations in which the baseball events and activities may be held, may not comply fully with the COVID-19 Protocols. I understand that the implementation of the COVID-19 Protocols does not guarantee that I (including my children) will not be exposed to or contract COVID-19 as a result of their attendance in the baseball events and activities or pass COVID-19 on to others, including myself and other family members of me or my children. I understand and knowingly and voluntarily assume all risks related to traveling to and from, and participating in the baseball events and activities. Those risks may include an increased risk of exposure to illness (including, but not limited to, COVID-19), personal injury, disability, and other short-term or long-term health effects including death, which might result not only from me or my child's own actions, inactions or negligence, but from the actions, inactions or negligence of any of the Releasees (as defined below). I accept that we have personal responsibility for any and all costs and expenses, damages, liability, and other losses that we may incur in connection with the risks described above.

In consideration for my participation in the baseball events and activities sponsored by Sansei Baseball League, I, on behalf of myself, the below named minors, my children, my parents, my heirs, assigns, personal representatives and estate, do HEREBY RELEASE, WAIVE, DISCHARGE, INDEMNIFY, HOLD HARMLESS AND COVENANT NOT TO SUE Sansei Baseball League, the Los Angeles Unified School District, the Torrance Unified School District, the City of Torrance, and each of its members, directors, board, officers, coaches, officials, sponsors, agents, vendors, faculty, employees, and administrators (referred herein collectively for all purposes as "Releasees"), of and from any and all demands, actions, causes of action, claims of any kind or nature whatsoever, known and unknown, anticipated or unanticipated, past or present, pertaining to the claim for injuries and damages which may exist arising out of or related to the participation in the baseball events and related activities of Sansei Baseball League caused or alleged to be caused in whole

or in part by the negligence or acts of the Releasees, attending public, spectators, coaches, and/or player participants.

If, despite this release, I, on behalf of myself, my children, my parents, my heirs, assigns, personal representatives and estate, make a claim against any of the Releasees, then I, on behalf of myself, my children, my parents, my heirs, assigns, personal representatives and estate will defend, indemnify and hold harmless Releasees for any and all damages, attorneys' fees, and costs incurred as a result of said claim.

I, on behalf of myself, my children, my parents, my heirs, assigns, personal representatives and estate understand that photographs, videotapes, and other recordings may be made of me. I, on behalf of myself, my children, my parents, my heirs, assigns, personal representatives and estate, consent to the use by Sansei Baseball League of any photographs, pictures, film or videotape taken of me or provided by me for publicity, promotion, television, or any other use, and expressly waive any right of privacy, compensation, copyright or other ownership right connected to same.
